Please note summary of Public Decorum rules below.

Rule XVII: Decorum

*Any person who shall disturb the peace of the Council, make impertinent or slanderous remarks or conduct himself in a boisterous manner while addressing the Council shall be forthwith barred by the presiding officer from further audience before the Council, except that if the speaker shall submit to proper order under these rules, permission for him to continue may be granted by a majority vote of the Council.*

*City Council meetings shall be conducted in a courteous manner. Citizens and Council members will be allowed to state their positions in an atmosphere free of slander, threats of violence or the use of Council as a forum for politics. Sufficient warnings may be given by the Chair at any time during the remarks and, in the event that any individual shall violate the rules of decorum heretofore set forth, the Chairperson may then cut off comment or debate. At the discretion of the Chairperson, light signals may be used to display the commencement of the time for speaking and a warning light may be flashed to show that the appropriate time has passed. A red light will signal that there is no longer time.*

**ORDINANCE AMENDING CHAPTER 573, PEACE AND GOOD ORDER; GAMBLING,  
TO AMEND, EMPHASIZE, SUPPLEMENT AND CLARIFY THAT ILLEGAL  
GAMBLING IN PRIVATE AND PUBLIC PLACES IS PROHIBITED IN THE CITY OF  
CAMDEN AND THE PENALTIES TO BE IMPOSED.**

WHEREAS, this City Council of the City of Camden has determined that it is in the best interests of the City of Camden that Chapter 573 of the Camden Code; Peace and Good Order, Gambling, be amended and supplemented to clarify and further provide that it shall be illegal to gamble in a private as well as a public place in the City of Camden unless authorized pursuant to Chapter 410 of the Camden Code; Games of Chance; and

WHEREAS, this amendment, supplementation and clarification is supported by and in furtherance of New Jersey statute, N.J.S.A. 2C: 37-2; Promoting Gambling, now therefore

BE IT ORDAINED by the City Council of the City of Camden that it hereby amends, supplements and clarifies Chapter 573; Peace and Good Order, Gambling, as follows:

**CHAPTER 573. PEACE AND GOOD ORDER**

**ARTICLE I. GENERAL REGULATIONS**

**§ 573-4. Gambling.**

- A. Subject to Chapter 410; Games of Chance, herein, no person shall set up, keep, maintain or permit to be set up, kept or maintained in any house, room, hall, place of business or other premises any faro table, faro bank, roulette, craps, blackjack, baccarat, any sidewalk dice game, or any other device or game of chance for the purpose of gambling.
- B. Subject to Chapter 410; Games of Chance, herein, no person shall deal, play or engage in faro, roulette, craps, blackjack, baccarat, any sidewalk dice game, or other game of chance, either as banker, player, dealer or otherwise, for the purpose of gambling.
- C. Subject to Chapter 410; Games of Chance, herein, no person shall deal, play or engage in faro, roulette, craps, blackjack, baccarat, any sidewalk dice game, or other game of chance, either as banker, player, dealer or otherwise, for the purpose of gambling in any public place.
- D. Violations and penalties.
  - 1. Any person violating any provision of § 573-4 shall, upon conviction, shall be subject to the penalties imposed in accordance with the provisions of section 1-15.

**ORDINANCE AMENDING CHAPTER 716 OF THE CAMDEN CITY CODE; SPECIAL EVENTS, TO SPECIFY THE OBLIGATIONS OF THE LICENSEE OR PERMIT RECIPIENT OF THE SPECIAL EVENT AND TO INCLUDE RETAINAGE, SUSPENSION AND POSSIBLE FINE FOR VIOLATING THE TERMS OF THE LICENSE OR PERMIT FOR THE SPECIAL EVENT**

WHEREAS, the City Council of the City of Camden established Chapter 716 of the Camden City Code covering Special Events; and

WHEREAS, some of these events have led to trash or other debris being left behind at the location of the special event, including but not limited to ballfields; and

WHEREAS, the City Council of the City of Camden now seeks to amend Chapter 716 to specify that the obligation of the licensee or person receiving the permit for the special event includes the obligation to ensure that the location of the event, including but not limited to ballfields, to completely cleaned up the site of the special event and dispose of all trash, waste and debris before leaving the event site; and

WHEREAS, the City Council of the City of Camden also seeks to require each application for a special event to also include a retainage amount to be established by the Administration, depending on the specific event being sought, which shall only be returned in instances where the event location has been completely cleaned up and all trash, waste and debris disposed of, promptly after the event ends; and

WHEREAS, the City Council of the City of Camden also seeks to require applicants to obtain signatures from at least fifty-one percent (51%) of the property owners and renters who reside within two hundred (200) feet of the proposed special event location or the surrounding neighborhood before the City can issue a permit; which will require each such application for this certain special event to provide documentation at the time of the submission of the application, indicating that the applicant has provided written notice to all property owners and renters who reside within two hundred (200) feet of the event's proposed location or the surrounding neighborhood, and such notice shall specifically indicate the information, as provided for in this amendment; and

WHEREAS, the City Council of the City of Camden also seeks to indicate that a license or permit issued for a special event may be suspended or revoked if the applicant violates the terms of the issued license or permit, including but not limited to the failure of the licensee or person obtaining the permit to ensure that the event location has been completely cleaned up and all trash, waste and debris disposed of, promptly after the event ends; now therefore

BE IT ORDAINED by the City Council of the City of Camden that Chapter 716 of the Camden Code is amended as follows:

**CHAPTER 716 SPECIAL EVENTS**

**§716-1. Definitions.**

RETAINAGE – amount established by the Special Events Review Committee which shall be required at the time of application submission which shall be temporarily withheld until the Special Event or Special Event dates have been concluded, to ensure that the event location has been completely cleaned up and that all trash, waste and debris has been promptly disposed following the event(s).

SPECIAL EVENT REQUIRING PUBLIC NOTICE – those special events, as defined in this section, in which the Administration has established a policy and procedure specifying that this special event requires notice to the public before an application is approved and such policy and procedure shall, at a minimum, include that such notice shall specifically state: (1) the location and time(s) of the special event; (2) that any person may object to such application being approved by advising the Special Events Review Committee in writing of their objections within ten (10) days of receipt of such notice; and (3) that the business e-mail and business address of the Special Events Review Committee shall be included in the notice for purposes of allowing any person to file an objection.

**ORDINANCE AMENDING CHAPTER 675 TO SPECIFICALLY INCLUDE UNTREATED WATER, WASTEWATER AND OTHER WASTE PRODUCTS CONTAINED IN THE UNTREATED WATER OR WASTEWATER ARISING FROM A MOBILE COMMERCIAL CAR WASH AS CONTAMINANTS PROHIBITED FROM ENTERING THE CITY'S PUBLIC SEWER AND STORMWATER SYSTEM**

WHEREAS, Section 675-4 and Section 675-5 of the Camden Code include a variety of contaminants that cannot be discharged into the City's public sewer or stormwater system; and

WHEREAS, commercial car wash run-off includes but is not limited to the following contaminants: phosphorus, alkylphenol ethoxylates (APEs), petroleum distillates, detergents and other forms of debris; and

WHEREAS, while not specifically indicating same, the contaminants described in Section 675-4 and Section 675-5 already include the contaminants found in untreated water, wastewater and other waste products contained in the untreated water or wastewater arising from commercial car wash run-off; and

WHEREAS, the Clean Water Act also prohibits the contaminants found in untreated water, wastewater and other waste products contained in the untreated water or wastewater arising from commercial car wash run-off from entering the City's public sewer and stormwater system; and

WHEREAS, the purpose of this amendment is to express with precision and clarity that the contaminants found in untreated water, wastewater, and other waste products contained in the untreated water or wastewater arising from commercial car wash run-off fall within the contaminants described in Section 675-4 and Section 675-5.

NOW THEREFORE, BE IT ORDAINED by the City Council of the City of Camden that Section 675-1; Definitions, and Section 675-5, Deposit of wastes in drainage and sewage inlets, are amended as follows:

Part I Sewer Use, Charges and Construction

Article I Use Regulations

§ 675-1. Definitions.

The definitions section is amended to now also include:

Mobile Commercial Washing refers to any activity conducted for compensation in any form whatsoever that involves the washing of automobiles, trucks, motorcycles, recreational vehicles or any other vehicles and includes any business or operation that operates at one location in the City of Camden including at the owner or operator of the mobile car wash's residence and serves customers or which moves from one location to another and serves customers at their residences or places of work. Mobile Car Washing shall not include: (1) a building or structure which contains approved facilities for washing, cleaning and drying of vehicles; (2) non-commercial residential car washing; or (3) any temporary car wash event conducted for the sole purpose of fundraising for a charitable organization, association or other similar entity.

B. No person shall discharge or cause to be discharged any of the following into sewers, and into drainage or sewage inlets or into any place where such matter may be carried into the inlets:

1. Any untreated water, wastewater or other waste particles contained in the untreated water or wastewater arising from the mobile commercial washing of automobiles, trucks, motorcycles, recreational vehicles or any other vehicles.

C. Before operating in the City of Camden, any mobile commercial car wash owner or operator must:

- a. Obtain a mercantile license from the Department of Code Enforcement; and
- b. Seek approval from the Department of Health and the Department of Public Works indicating that the water treatment, purification and filtration system being utilized by that commercial car wash owner or operator is sufficient and adequate to remove the contaminants described in Section 675-4 above and in this Section, from any possible commercial car wash run-off.

- Pursuant to NJSA 54:4-99 and 54:4-100, the City offers a Lien Reduction program that allows delinquent property owners to request that liens be reduced to the fair market value of the property.
- The owner of 1211 Chestnut submitted a Lien Reduction Application to the Lien Review Committee to reduce the amount of the \$70,291.10 tax lien to the fair market value of \$21,000.00
- The Lien Review committee reviewed the application and appraisal report prepared by a NJ licensed appraiser, and is satisfied that the principal amount of the lien (\$24,464.73) exceeds the fair market value of the lien (\$21,000.00) pursuant to 54:4-100. As such, the Tax Collector is requesting that the lien be reduced to the fair market value of the property pursuant to N.J.S.A. 54:4-99 and 54:5-100.

**LICENSE AGREEMENT  
BY AND BETWEEN  
THE CITY OF CAMDEN AND THE COUNTY OF CAMDEN  
FOR ACCESS TO VARIOUS CITY-OWNED LOTS**

This License Agreement (the "Agreement") is made on the \_\_\_\_\_ day of \_\_\_\_\_, 2025, by and between the City of Camden ("Licensor"), 520 Market Street, Camden, NJ 08102, a municipal corporation of the State of New Jersey and the County of Camden ("Licensee"), a body politic and corporate of the State of New Jersey, 520 Market Street, 6<sup>th</sup> Floor, Camden, New Jersey 08102, hereinafter referred to as "Parties".

WHEREAS, Licensor is the owner of certain real property (the "Premises") in the City of Camden that will be used for Temporary Parking Lots during the Haddon Avenue, Improvements Project ("Project"), Exhibit A which is incorporated by reference and attached hereto contains a list of the Temporary Parking Lot locations in the City.

WHEREAS, Licensor agrees to grant the Licensee and its agents, employees and third-party contractors a right of entry upon and license to the Premises for the purpose of installing and operating Temporary Parking Lots during the Project.

NOW THEREFORE, in consideration of the mutual promises, covenants and obligations and agreements made and contained herein, and intending to be legally bound hereby, the Parties hereto agree as follows:

**1. Scope of License**

Licensor hereby grants Licensee and its agents, employees and third-party contractors access to the Premises for the purpose of installing and operating Temporary Parking Lots during the Project.

**2. Performance**

Licensee agrees the Project will be performed in a good and workmanlike manner and in accordance with the applicable requirements of the City of Camden Code.

**3. Term**

The term of the Agreement shall be for a period of five (5) years, commencing on or about **June 1, 2025**, through **May 31, 2030**, with the option to terminate the Agreement upon sixty (60) days' written notice by either party. However, in the event that the Temporary Parking Location is no longer owned by the City, this portion of the Agreement with to that specific location will be null and void.

**4. License Fee**

There shall be no license fee due Licensor from Licensee arising from the Agreement.

5. **Compliance with Laws**

Licensee shall observe and comply with all state, local and federal laws and the rules of any governing body having jurisdiction over the Premises and/or its use.

6. **Signage**

Licensors will provide the language for signage at the Temporary Parking Lots and Licensee will make the Signs. Licensors will install all signage at the Temporary Parking Lots.

7. **Indemnification**

The County of Camden shall indemnify, defend and hold harmless the City of Camden, its offices, agents and employees from any and all claims and costs of any nature whether for personal injury, property damage or other liability arising out of or in any way connected with the negligent acts or omissions of the County, its employees, agents, invitees and/or subcontractors in connection with this agreement.

The City of Camden shall indemnify, defend and hold harmless the County of Camden, its offices, agents and employees from any and all claims and costs of any nature whether for personal injury, property damage or other liability arising out of or in any way connected with the negligent acts or omissions of the City, its employees, agents, invitees and/or subcontractors in connection with this agreement.

8. **Insurance**

Licensee hereby agrees to carry and maintain in full force and effect, for the duration of the License Agreement and any supplement thereto, insurance in the following amount:

- General Liability - \$1,000,000/\$3,000,000
- Workers Compensation – Statutory Limits
- Commercial Auto Liability - \$1,000,000

Licensee will cause the City of Camden, all elected and appointed officials, employees and volunteers to be named as an additional insured in the above policies on a primary, non-contributory basis and provide the Licensors with the Certificate of Insurance. The Certificate of Insurance is contained in Exhibit B which is incorporated by reference and attached hereto.

Licensee must notify the Licensors immediately of any material change in insurance coverage such as changes in limits, coverages, status of policy, etc. The Licensors reserves the right to request complete copies of insurance policies at all times.

9. **Assignment of License**

This License Agreement may not be assigned.

10. Revocation of License

It is hereby understood and agreed that Licensor reserves the right to revoke the right of entry and license provided to Licensee under the terms of the Agreement at any time, for violation of this License Agreement or other good cause, upon giving thirty (30) days written notice and the opportunity to cure to the violation. In the event that Licensee fails to cure the violation, and Licensor exercises its right to revoke the right of entry and license provided to Licensee under the Agreement, Licensee shall retain no other access or rights to the Premises. Upon revocation or expiration of this License Agreement, Licensee shall have no obligation to return the space to its original condition.

This agreement, hereinafter referred to as the AGREEMENT, made at Philadelphia, Pennsylvania, on \_\_\_\_\_, 2025 (the "Effective Date"), by and between the Delaware Valley Regional Planning Commission ("COMMISSION"), a body politic and corporate, created and vested sovereign immunity by Act No. 103 of June 30, 1965, P.L. 153, reenacted and amended by Act 43 of June 30, 1967, P.L. 155, of the Session of the General Assembly of Pennsylvania, and the Legislature of the State of New Jersey in Chapter 149 of the Laws of 1966, as amended and supplemented, having its principal office at the American College of Physicians Building, 190 N. Independence Mall West, 8<sup>th</sup> Floor, Philadelphia, Pennsylvania 19106;

AND

City of Camden, New Jersey, having its principal office at 520 Market Street, City Hall, Room 224, Camden, New Jersey 08101-5120, hereinafter referred to as the PROJECT SPONSOR.

## WITNESSETH:

WHEREAS, the COMMISSION has entered into Agreement with the William Penn Foundation, hereinafter referred to as the AGENCY, whereby the COMMISSION is to perform certain obligations under its Agreement in the accomplishment of a grant from the AGENCY; and

WHEREAS, the PROJECT SPONSOR will perform certain services through this AGREEMENT in connection with Project No. 24-33-254, "Burlington-Camden Trail - 32nd to 36th Street," hereinafter referred to as the PROJECT; and

WHEREAS, the PROJECT SPONSOR has been selected by the COMMISSION's Regional Trails Project Selection Committee and approved by the COMMISSION's Board; and

WHEREAS, the PROJECT will be coordinated by the COMMISSION's Executive Director, or designee, with other elements of the COMMISSION's overall program of regional planning, to avoid duplication of effort and to ensure that all activities in the program are compatible and interrelated; and

WHEREAS, consistent with the COMMISSION's responsibilities to the AGENCY, as its agent and coordinator for the PROJECT, the PROJECT SPONSOR shall be responsible for the technical direction, management and conduct of the PROJECT and administratively responsible to the COMMISSION.

NOW, THEREFORE, in consideration of the foregoing and of the mutual promises hereinafter expressed, and intending to be legally bound hereby, the parties hereto agree as follows:

## **1 GENERAL CONDITIONS**

---

- A. The COMMISSION hereby agrees to engage the PROJECT SPONSOR and the PROJECT SPONSOR agrees to perform such services as are specified in: (1) this AGREEMENT; (2) Exhibit A, Scope of Work and Budget; and (3) Exhibit B, the Standard Articles of Agreement for William Penn Foundation Regional Trails. Exhibit A and Exhibit B are attached hereto and are incorporated by reference.
- B. All modifications, changes, and/or additions to this AGREEMENT shall be effectuated in accordance with Article 5: Changes and Amendments of the Standard Articles of Agreement for William Penn Foundation Regional Trails and shall not be binding unless approved in writing by the COMMISSION.

## **2 PROJECT FUNDING**

---

The total PROJECT budget shall be Two Hundred Thousand Dollars (\$200,000) with approved funding as follows:

Funds Provided by AGENCY: \$200,000

Funding Source: William Penn Foundation

**Total Amount: \$200,000**

## **3 CONTRACT AMOUNT AND PAYMENT TERMS**

---

- A. The amount payable by the COMMISSION to the PROJECT SPONSOR shall not exceed Two Hundred Thousand Dollars (\$200,000).
- B. Payment to the PROJECT SPONSOR for work performed shall be on a cost-reimbursable basis with payments based on the submission of invoices and progress reports

documenting the work completed during the period reported, in accordance with approved budget.

#### **4 ADMINISTRATION OF AGREEMENT**

---

- A. The Executive Director of the COMMISSION, or his/her designee shall be the authorized agent to act on behalf of the COMMISSION in the administration of this AGREEMENT, and shall give notices, issue change orders, and otherwise represent the COMMISSION in the negotiation of matters arising out of this AGREEMENT.
- B. The Principal of the PROJECT SPONSOR, or his/her designee, shall be the authorized agent to act on behalf of the PROJECT SPONSOR in the administration of this AGREEMENT and in the negotiation of matters arising out of this AGREEMENT.

#### **5 TIME OF PERFORMANCE**

---

- A. The PROJECT SPONSOR shall commence work upon the Effective Date of the AGREEMENT. The PROJECT SPONSOR shall complete work on the PROJECT no later than 12/31/2026.

#### **6 COORDINATION OF COOPERATION**

---

- A. The PROJECT SPONSOR agrees to provide the COMMISSION with sufficient copies of all materials and documents, in a timely manner, which are necessary for the COMMISSION to meet its obligations to the AGENCY.

#### **7 TITLE VI POLICY AND SELF-CERTIFICATION**

---

- A. The COMMISSION has adopted the following policy statement as part of its Title VI Compliance Plan:

The Delaware Valley Regional Planning Commission (DVRPC) assures that no person shall on the grounds of race, color, or national origin, as provided by Title VI of the Civil Rights Act of 1964, and the Civil Rights Restoration Act of 1987 (P.L. 100.259), be excluded from participation in, be denied the benefits of, or be otherwise subjected to discrimination under any agency-sponsored program or activity. Nor shall sex, age, or disability stand in the way of fair treatment of all individuals.

The COMMISSION further assures that every effort will be made to ensure nondiscrimination in all of its programs and activities, whether those programs and activities are federally funded or not.

In the event that the COMMISSION distributes federal aid funds to another entity, the COMMISSION will include Title VI language in all written agreements and will monitor for

compliance. Title VI compliance is a condition of the receipt of federal funds. The COMMISSION's Executive Director and Title VI Compliance Manager are authorized to ensure compliance with provisions of this policy and with the law, including the requirements of Title 23 Code of Federal Regulations (CFR) 200 and Title 49 CFR 21.

The COMMISSION acknowledges its responsibility for initiating and monitoring Title VI activities, preparing required reports and other responsibilities as required by Title 23 Code of Federal Regulations (CFR) 200 and by Title 49 CFR Part 21.

The COMMISSION requires verification of the compliance of PROJECT SPONSOR with Title VI provisions of the Civil Rights Act of 1964, per state and federal guidance for all new contracts entered into by the COMMISSION. The COMMISSION reserves the right to conduct subsequent Title VI compliance reviews on any PROJECT SPONSOR during a contract.

B. As part of its verification of compliance with Title VI, the COMMISSION requires the following Self-Certification. All duly authorized representatives of the PROJECT SPONSOR must certify that:

1. The PROJECT SPONSOR understands that compliance with Title VI of the Civil Rights Act of 1964 {42 U.S.C. 2000d}, the Civil Rights Restoration Act of 1987, and other nondiscrimination statutes is a requirement for receiving federal funds.
2. During the performance of this contract, the PROJECT SPONSOR, for itself, its assignees, and successors in interest, agree as follows:
  - a. Compliance with Regulations

The PROJECT SPONSOR shall comply with the Regulations relative to nondiscrimination in federally assisted programs of the Department of Transportation (hereinafter referred to as DOT), Title 49, Code of Federal Regulations, Part 21, as they may be amended from time to time, (hereinafter referred to as the Regulations), which are herein incorporated by reference and made a part of this contract.

- b. Nondiscrimination

The PROJECT SPONSOR, with regard to the work performed by it during the contract, shall not discriminate on the grounds of race, color, sex, or national origin in the selection and retention of subcontractors, including procurement of materials and leases of equipment. The PROJECT SPONSOR shall not participate either directly or indirectly in discrimination prohibited by Section 21.5 of the Regulations, including employment practices when the contract covers a program set forth in Appendix B of the Regulations. 3. Solicitations for Subcontracts, Procurement of Materials & Equipment. In all solicitations either by competitive bidding or

negotiations made by the PROJECT SPONSOR for work to be performed under a subcontract, including procurement of materials or leases of equipment, each potential subcontractor or supplier shall be notified by the PROJECT SPONSOR of the PROJECT SPONSOR obligations under this contract and the Regulations relative to nondiscrimination on the ground of race, color, sex, or national origin.

c. Information and Reports

The PROJECT SPONSOR shall provide all information and reports required by the Regulations or directives issued pursuant thereto, and shall permit access to its books, records, accounts, other sources of information and its facilities as may be determined by appropriate federal or state agency to be pertinent to ascertain compliance with such Regulations, orders, and instructions. Where any information required of a PROJECT SPONSOR is in the exclusive possession of another who fails or refuses to furnish this information, the PROJECT SPONSOR shall so certify to appropriate federal or state agency as appropriate, and shall set forth what efforts it has made to obtain the information.

d. Sanctions for Noncompliance

In the event of the PROJECT SPONSOR noncompliance with the nondiscrimination provisions of this contract, DVRPC shall impose such contract sanctions as it or the appropriate federal or state agency may determine to be appropriate, including, but not limited to, withholding of payments to the PROJECT SPONSOR under the contract until the PROJECT SPONSOR complies; and/or cancellation, termination, or suspension of the contract, in whole or in part.

e. Incorporation of Provisions

The PROJECT SPONSOR shall include the provisions of paragraphs (1) through (5) in every subcontract, including procurement of materials and leases of equipment, unless exempt by the Regulations, or directives issued pursuant thereto. The PROJECT SPONSOR shall take such action with respect to any subcontractor or procurement as may direct as a means of enforcing such provisions including sanctions for noncompliance. Provided, however, that in the event a PROJECT SPONSOR becomes involved in, or is threatened with, litigation with a subcontractor or supplier as a result of such direction, the PROJECT SPONSOR may request DVRPC enter into such litigation to protect the interests of the state and, in addition, the PROJECT SPONSOR may request the United States to enter into such litigation to protect the interests of the United States.

3. The PROJECT SPONSOR will ensure that, as per paragraph 6 above, paragraphs 1-5 will be included in all subcontracts.

## **8 INSURANCE AND INDEMNIFICATION**

---

- A. As outlined in Article 1.10 of the Standard Articles of Agreement for William Penn Foundation Regional Trails, the PROJECT SPONSOR hereby agrees to provide adequate liability insurance and workers compensation coverage for its employees working on the PROJECT. The PROJECT SPONSOR must provide a certificate of insurance to COMMISSION. If the PROJECT SPONSOR is self-insured, a letter to COMMISSION stating such shall be provided.
- B. Attention is called to Article 1.11 of the Standard Articles of Agreement for William Penn Foundation Regional Trails, providing for the PROJECT SPONSOR's indemnification of the COMMISSION and the AGENCY.

## **9 SPECIAL CONDITIONS**

---

- A. The PROJECT SPONSOR must submit its detailed scopes of work and budget proposals, and if applicable, those for all subcontractors being utilized in the performance of the PROJECT. These documents shall be forwarded to COMMISSION for review and approval prior to issuance of cost reimbursements.
- B. The PROJECT SPONSOR shall ensure Circuit Trails signs or the Circuit Trails logos are included in the signing and pavement marking plan for the proposed trail. Circuit Trails signs and logos may be integrated with planned local trail signage programs. Circuit Trails sign templates and graphic files are available from Anya Saretsky (anya@railstotrails.org) of the Rails-to-Trails Conservancy.
- C. Attention is called to Article 15, Publicity, of Exhibit B, the Standard Articles of Agreement for William Penn Foundation Regional Trails. The PROJECT SPONSOR shall inform COMMISSION of any events related to this funding, including, but not limited to, ground breakings and ribbon cuttings. PROJECT SPONSOR shall inform COMMISSION of any events related to this funding, including, but not limited to, ground breakings and ribbon cuttings.
- D. By executing this AGREEMENT, the PROJECT SPONSOR hereby specifically agrees to Article 12: U.S. Department of Transportation Standard Title VI and Non-Discrimination Assurances of Exhibit B, the Standard Articles of Agreement for William Penn Foundation Regional Trails.
- E. Electronic, digital, or pdf signatures delivered by email shall constitute a legal and binding signature to this AGREEMENT.
- F. This Agreement will be governed by the laws of the Commonwealth of Pennsylvania.

WHEREAS, Camden Heights LLC, a New York limited liability company (hereinafter referred to as the "Sponsor") proposes to acquire and provide rehabilitate the property consisting of 80 affordable housing units commonly known as Lakeshore Club Apartments (hereinafter referred to as the "Project") pursuant to the provisions of the New Jersey Housing and Mortgage Finance Agency Law of 1983, as amended (N.J.S.A. 55:14K-1 et seq.), the rules promulgated thereunder at N.J.A.C. 5:80-1 et seq., and all applicable guidelines (the foregoing hereinafter referred to as the "HMFA Law") located within the City of Camden, County of Camden, New Jersey (hereinafter referred to as the "City") on a site described as Block 632, Lot 44 and Block 640, Lot 25 as shown on the Official Assessment Map of the City of Camden and commonly known as 1310-1355 Fairview Street, Camden, New Jersey, 08104; and

WHEREAS, the Project will be subject to the HMFA Law and the mortgage and other loan documents executed between the Sponsor and the New Jersey Housing and Mortgage Finance Agency (hereinafter referred to as the "Agency"); and

WHEREAS, pursuant to the HMFA Law, the City Council of the City of Camden hereby determines that there is a need for this housing project in the City; and

WHEREAS, the Sponsor has presented to the City Council a revenue projection for the Project which sets forth the anticipated revenue to be received by the Sponsor from the operation of the Project as estimated by the Sponsor and the Agency, a copy of which is attached hereto and made a part hereof as Exhibit A; now, therefore


BE IT RESOLVED by the City Council of the City of Camden (the "City Council") that:

1. The City Council does hereby adopt the within Resolution with the further intent and purpose that from the date of execution of the Agency mortgage, the proposed Project, including both the land and improvements thereon, will be exempt from real property taxation as provided in the HMFA Law, provided that payments in lieu of taxes for municipal services supplied to the Project are made to the City in such amounts and manner set forth in the Agreement for Payments in Lieu of Taxes attached hereto as Exhibit "B" (the "PILOT Agreement"); and
2. The Council hereby authorizes and directs the Mayor of the City of Camden to execute, on behalf of the City, the PILOT Agreement in substantially the form annexed hereto as Exhibit "B"; and
3. The City Council understands and agrees that the revenue projections set forth in Exhibit "A" to the PILOT Agreement are estimates and that the actual payments in lieu of taxes to be paid by the Sponsor to the City shall be determined pursuant to the PILOT Agreement executed between the Sponsor and City.

BE IT FURTHER RESOLVED, that pursuant to N.J.S.A. 52:27BBB-23, a true copy of this Resolution shall be forwarded to the State Commissioner of Community Affairs, who shall have ten (10) days from the receipt thereof to veto this Resolution. AGREEMENT FOR PAYMENT IN LIEU OF TAXES

THIS AGREEMENT, made this \_\_\_\_ day of \_\_\_\_\_, 2025, between Camden Heights LLC, having an office at 100 Henry Street, Brooklyn, New York 11201 (hereinafter the "Sponsor") and the City of Camden, a municipal corporation in the County of Camden and State of New Jersey (hereinafter the "City").

WITNESSETH

In consideration of the mutual covenants herein contained and for other good and valuable consideration, it is mutually covenanted and agreed as follows:

1. This Agreement is made pursuant to the authority contained in Section 37 of the New Jersey Housing and Mortgage Finance Agency Law of 1983 (N.J.S.A. 55:14K-1 et seq.) (hereinafter "HMFA Law") and a Resolution of the City Council duly adopted on \_\_\_\_\_, 2025, (the "Resolution") and with the approval of the New Jersey Housing and Mortgage Finance Agency (hereinafter the "Agency"), as required by N.J.S.A. 55:14K-37.

2. The Project is or will be situated on that parcel of land designated as Block 632, Lot 44, and Block 640, Lot 25, as shown on the Official Assessment Map of the City of Camden, and more commonly referred to as 1310-1355 Fairview Street, Camden, New Jersey 08104 and currently known as "Lakeshore Apartments."

3. As of the date the Sponsor executes a first mortgage upon the Project in favor of the Agency (hereinafter referred to as the "Agency Mortgage"), the land and improvements comprising the Project shall be exempt from real property taxes, provided that the Sponsor shall make payments in lieu of taxes to the City as provided hereinafter. Except as set forth in Section 6 of this Agreement the exemption of the Project from real property taxation and the sponsor's obligation to make payments in lieu of taxes shall not extend beyond the date on which the Agency Mortgage is paid in full, which, according to the HMFA Law, may not exceed fifty (50) years.

4. (a) For projects receiving construction and permanent financing from the Agency, the Sponsor shall make payment to the City of an annual service charge in lieu of taxes in such amount as follows:

- (1) From the date of the execution of the Agency Mortgage until the date of Substantial Completion of the Project, the Sponsor shall make payment to the City in the amount equal to the current real estate taxes (pursuant to the HMFA Law, the annual amount may not exceed the amount of taxes due on the property for the year preceding the recording of the Agency Mortgage). As used herein, "Substantial Completion" means the date upon which the City issues the Certificate of Occupancy for all of the units in the Project.
- (2) From the date of Substantial Completion of the Project and for the remaining term of the NJHMFA Mortgage, the Sponsor shall make payment to the City

in an amount equal to seven point eight (7.8%) of Project Revenues.

(b) For Projects receiving permanent financing only from the Agency, the Sponsor shall make payment to the City in an amount equal to seven point eight (7.8%) of Project Revenues from the date of the Agency Mortgage and for the remaining term of the Agency Mortgage.

(c) As used herein, "Project Revenues" means the total annual gross rental or carrying charge or other income of the Sponsor from the Project less the costs of utilities furnished by the Project, which shall include the costs of gas, electricity, heating fuel, water supplied, and sewage charges, and less vacancies if any. Project Revenues shall not include any rental subsidy contributions received from any federal or state program.

(d) The amount of payment in lieu of taxes to be paid pursuant to paragraphs (a) or (b) and (c) above is calculated in Exhibit "A" attached hereto. It is expressly understood and agreed that the revenue projections provided to the City as set forth in Exhibit "A" and as part of the Sponsor's application for an agreement for payments in lieu of taxes are estimates only. The actual payments in lieu of taxes to be paid by the Sponsor shall be determined pursuant to Section 5 below.

5. (a) Payments by the Sponsor shall be made on a quarterly basis in accordance with bills issued by the Tax Collector of the City in the same manner and on the same dates as real estate taxes are paid to the City and shall be based upon Project Revenues of the previous quarter. No later than three (3) months following the end of the first fiscal year of operation after (i) the date of Substantial Completion (for projects receiving construction and permanent financing) or (ii) the date of the Agency Mortgage (for projects receiving permanent financing only) and each year thereafter that this Agreement remains in effect, the Sponsor shall submit to the City a certified, audited financial statement of the operation of the Project (the "Audit"), setting forth the Project Revenues and the total payments in lieu of taxes due to the City calculated at seven point eight (7.8%) of Project Revenues as set forth in the Audit (the "Audit Amount"). The Sponsor simultaneously shall pay the difference, if any, between (i) the Audit Amount and (ii) payments made by the Sponsor to the City for the preceding fiscal year. The City may accept any such payment without prejudice to its right to challenge the amount due. In the event that the payments made by the Sponsor for any fiscal year shall exceed the Audit Amount for such fiscal year, the City shall credit the amount of such excess to the account of the Sponsor.

(b) All payments pursuant to this Agreement shall be in lieu of taxes and the City shall have all the rights and remedies of tax enforcement granted to Municipalities by law just as if said payments constituted regular tax obligations on real property within the City. If, however, the City disputes the total amount of the annual payment in lieu of taxes due it, based upon the Audit, it may apply to the Superior Court, Chancery Division for an accounting of the service charge due the City, in accordance with this Agreement and HMFA Law. Any such action must be commenced within one year of the receipt of the Audit by the City.

(c) In the event of any delinquency in the aforesaid payments, the City shall give notice to the Sponsor and NJHMFA in the manner set forth in 9(a) below, prior to any legal action being taken.

6. The tax exemption provided herein shall apply only so long as the Sponsor or its successors and assigns and the Project remain subject to the provisions of the HMFA Law and Regulations made thereunder and the supervision of the Agency, but in no event longer than the term of the Agency Mortgage unless extended by the City pursuant to Section 37 c. of the HMFA Law. In the event of (a) a sale, transfer or conveyance of the Project by the Sponsor or (b) a change in the organizational structure of the Sponsor, this Agreement shall be assigned to the Sponsor's successor and shall continue in full force and effect so long as the successor entity qualifies under the HMFA Law or any other state law applicable at the time of the assignment of this Agreement and assumes the Agency Mortgage.

7. Upon any termination of such tax exemption, whether by affirmative action of the Sponsor, its successors and assigns, or by virtue of the provisions of the HMFA Law, or any other applicable state law, the Project shall be taxed as omitted property in accordance with the law.

8. The Sponsor, its successors and assigns shall, upon request, permit inspection of property, equipment, buildings and other facilities of the Project and also documents and papers by representatives duly authorized by the City. Any such inspection, examination or audit shall be made during reasonable hours of the business day, in the presence of an officer or agent of the Sponsor or its successors and assigns.

9. Any notice or communication sent by either party to the other hereunder shall be sent by certified mail, return receipt requested, addressed as follows:

(a) When sent by the City to the Sponsor, it shall be addressed to 100 Henry Street, Brooklyn, New York 11201 or to such other address as the Sponsor may hereafter designate in writing and a copy of said notice or communication by the City to the Sponsor shall be sent by the City to the New Jersey Housing and Mortgage Finance Agency, 637 South Clinton Avenue, P.O. Box 18550, Trenton, New Jersey 08650-2085.

(b) When sent by the Sponsor to the City, it shall be addressed to the Municipal Clerk, 520 Market Street, City Hall, Room 105, Camden, New Jersey 08102 or to such other address as the City may designate in writing; and a copy of said notice or communication by the Sponsor to the City shall be sent by the Sponsor to the New Jersey Housing and Mortgage Finance Agency, 637 South Clinton Avenue, P.O. Box 18550, Trenton, New Jersey 08650-2085.

10. In the event of a breach of this Agreement by either of the parties hereto or a dispute arising between the parties in reference to the terms and provisions as set forth herein, either party may apply to the Superior Court, Chancery Division, to settle and resolve said dispute in such fashion as will tend to accomplish the purposes of the HMFA Law.

11. This Agreement may be executed in any number of counterparts, each of which shall be deemed an original, but all of which together shall constitute one and the same agreement. It shall not be necessary in making proof of this Agreement to produce or account for more than a sufficient number of counterparts to evidence the execution of the Agreement by each party hereto.

## TAX ABATEMENT RESOLUTION

WHEREAS, Camden Heights LLC, a New York limited liability company (hereinafter referred to as the "Sponsor") proposes to acquire, and provide for the rehabilitation of, four (4) separate properties consisting of 290 affordable housing units (hereinafter referred to as the "Project") pursuant to the provisions of the New Jersey Housing and Mortgage Finance Agency Law of 1983, as amended (N.J.S.A. 55:14K-1 et seq.), the rules promulgated thereunder at N.J.A.C. 5:80-1 et seq., and all applicable guidelines (the foregoing hereinafter referred to as the "HMFA Law") located within the City of Camden, County of Camden, New Jersey (hereinafter referred to as the "City") on various parcels of real property more particularly described on Exhibit "A" hereto; and

- (1) The City Council does hereby adopt the within Resolution with the further intent and purpose that from the date of execution of the Agency mortgage, the proposed Project, including both the land and improvements thereon, will be exempt from real property taxation as provided in the HMFA Law, provided that payments in lieu of taxes for municipal services supplied to the Project are made to the City in such amounts and manner set forth in the Agreement for Payments in Lieu of Taxes attached hereto as Exhibit "B" (the "PILOT Agreement"); and
- (2) The City Council hereby authorizes and directs the Mayor of the City to execute, on behalf of the City, the PILOT Agreement in substantially the form annexed hereto as Exhibit "B"; and
- (3) The City Council understands and agrees that the revenue projections set forth in Exhibit "A" to the PILOT Agreement are estimates and that the actual payments in lieu of taxes to be paid by the Sponsor to the City shall be determined pursuant to the PILOT Agreement executed between the Sponsor and City.

## AGREEMENT FOR PAYMENT IN LIEU OF TAXES

THIS AGREEMENT, made this \_\_\_\_\_ day of \_\_\_\_\_, 2025, between Camden Heights LLC, having an office at 100 Henry Street, Brooklyn, New York 11201 (hereinafter the "Sponsor") and the City of Camden, a municipal corporation in the County of Camden and State of New Jersey (hereinafter the "City").

### WITNESSETH

In consideration of the mutual covenants herein contained and for other good and valuable consideration, it is mutually covenanted and agreed as follows:

1. This Agreement is made pursuant to the authority contained in Section 37 of the New Jersey Housing and Mortgage Finance Agency Law of 1983 (N.J.S.A. 55:14K-1 et seq.) (hereinafter "HMFA Law") and a Resolution of the City Council duly adopted on \_\_\_\_\_, 2025, (the "Resolution") and with the approval of the New Jersey Housing and Mortgage Finance Agency (hereinafter the "Agency"), as required by N.J.S.A. 55:14K-37.

2. The Project is or will be situated on that parcel of land designated as Block 632, Lot 44, and Block 640, Lot 25, as shown on the Official Assessment Map of the City of Camden, and more commonly referred to as 1310-1355 Fairview Street, Camden, New Jersey 08104 and currently known as "Macedonia Garden Apartments."

3. As of the date the Sponsor executes a first mortgage upon the Project in favor of the Agency (hereinafter referred to as the "Agency Mortgage"), the land and improvements comprising the Project shall be exempt from real property taxes, provided that the Sponsor shall make payments in lieu of taxes to the City as provided hereinafter. Except as set forth in Section 6 of this Agreement the exemption of the Project from real property taxation and the sponsor's obligation to make payments in lieu of taxes shall not extend beyond the date on which the Agency Mortgage is paid in full, which, according to the HMFA Law, may not exceed fifty (50) years.

4. (a) For projects receiving construction and permanent financing from the Agency, the Sponsor shall make payment to the City of an annual service charge in lieu of taxes in such amount as follows:

- (1) From the date of the execution of the Agency Mortgage until the date of Substantial Completion of the Project, the Sponsor shall make payment to the City in the amount equal to the current real estate taxes (pursuant to the HMFA Law, the annual amount may not exceed the amount of taxes due on the property for the year preceding the recording of the Agency Mortgage). As used herein, "Substantial Completion" means the date upon which the City issues the Certificate of Occupancy for all of the units in the Project.
- (2) From the date of Substantial Completion of the Project and for the remaining term of the NJHMFA Mortgage, the Sponsor shall make payment to the City

in an amount equal to six point twenty-eight (6.28%) of Project Revenues.

(b) For Projects receiving permanent financing only from the Agency, the Sponsor shall make payment to the City in an amount equal to six point twenty-eight (6.28%) of Project Revenues from the date of the Agency Mortgage and for the remaining term of the Agency Mortgage.

(c) As used herein, "Project Revenues" means the total annual gross rental or carrying charge or other income of the Sponsor from the Project less the costs of utilities furnished by the Project, which shall include the costs of gas, electricity, heating fuel, water supplied, and sewage charges, and less vacancies if any. Project Revenues shall not include any rental subsidy contributions received from any federal or state program.

(d) The amount of payment in lieu of taxes to be paid pursuant to paragraphs (a) or (b) and (c) above is calculated in Exhibit "A" attached hereto. It is expressly understood and agreed that the revenue projections provided to the City as set forth in Exhibit "A" and as part of the Sponsor's application for an agreement for payments in lieu of taxes are estimates only. The actual payments in lieu of taxes to be paid by the Sponsor shall be determined pursuant to Section 5 below.

5. (a) Payments by the Sponsor shall be made on a quarterly basis in accordance with bills issued by the Tax Collector of the City in the same manner and on the same dates as real estate taxes are paid to the City and shall be based upon Project Revenues of the previous quarter. No later than three (3) months following the end of the first fiscal year of operation after (i) the date of Substantial Completion (for projects receiving construction and permanent financing) or (ii) the date of the Agency Mortgage (for projects receiving permanent financing only) and each year thereafter that this Agreement remains in effect, the Sponsor shall submit to the City a certified, audited financial statement of the operation of the Project (the "Audit"), setting forth the Project Revenues and the total payments in lieu of taxes due to the City calculated at six point twenty-eight (6.28%) of Project Revenues as set forth in the Audit (the "Audit Amount"). The Sponsor simultaneously shall pay the difference, if any, between (i) the Audit Amount and (ii) payments made by the Sponsor to the City for the preceding fiscal year. The City may accept any such payment without prejudice to its right to challenge the amount due. In the event that the payments made by the Sponsor for any fiscal year shall exceed the Audit Amount for such fiscal year, the City shall credit the amount of such excess to the account of the Sponsor.

(b) All payments pursuant to this Agreement shall be in lieu of taxes and the City shall have all the rights and remedies of tax enforcement granted to Municipalities by law just as if said payments constituted regular tax obligations on real property within the City. If, however, the City disputes the total amount of the annual payment in lieu of taxes due it, based upon the Audit, it may apply to the Superior Court, Chancery Division for an accounting of the service charge due the City, in accordance with this Agreement and HMFA Law. Any such action must be commenced within one year of the receipt of the Audit by the City.

(c) In the event of any delinquency in the aforesaid payments, the City shall give notice to the Sponsor and NJHMFA in the manner set forth in 9(a) below, prior to any legal action being taken.

6. The tax exemption provided herein shall apply only so long as the Sponsor or its successors and assigns and the Project remain subject to the provisions of the HMFA Law and Regulations made thereunder and the supervision of the Agency, but in no event longer than the term of the Agency Mortgage unless extended by the City pursuant to Section 37 c. of the HMFA Law. In the event of (a) a sale, transfer or conveyance of the Project by the Sponsor or (b) a change in the organizational structure of the Sponsor, this Agreement shall be assigned to the Sponsor's successor and shall continue in full force and effect so long as the successor entity qualifies under the HMFA Law or any other state law applicable at the time of the assignment of this Agreement and assumes the Agency Mortgage.

7. Upon any termination of such tax exemption, whether by affirmative action of the Sponsor, its successors and assigns, or by virtue of the provisions of the HMFA Law, or any other applicable state law, the Project shall be taxed as omitted property in accordance with the law.

8. The Sponsor, its successors and assigns shall, upon request, permit inspection of property, equipment, buildings and other facilities of the Project and also documents and papers by representatives duly authorized by the City. Any such inspection, examination or audit shall be made during reasonable hours of the business day, in the presence of an officer or agent of the Sponsor or its successors and assigns.

9. Any notice or communication sent by either party to the other hereunder shall be sent by certified mail, return receipt requested, addressed as follows:

(a) When sent by the City to the Sponsor, it shall be addressed to 100 Henry Street, Brooklyn, New York 11201 or to such other address as the Sponsor may hereafter designate in writing and a copy of said notice or communication by the City to the Sponsor shall be sent by the City to the New Jersey Housing and Mortgage Finance Agency, 637 South Clinton Avenue, P.O. Box 18550, Trenton, New Jersey 08650-2085.

(b) When sent by the Sponsor to the City, it shall be addressed to the Municipal Clerk, 520 Market Street, City Hall, Room 105, Camden, New Jersey 08102 or to such other address as the City may designate in writing; and a copy of said notice or communication by the Sponsor to the City shall be sent by the Sponsor to the New Jersey Housing and Mortgage Finance Agency, 637 South Clinton Avenue, P.O. Box 18550, Trenton, New Jersey 08650-2085.

10. In the event of a breach of this Agreement by either of the parties hereto or a dispute arising between the parties in reference to the terms and provisions as set forth herein, either party may apply to the Superior Court, Chancery Division, to settle and resolve said dispute in such fashion as will tend to accomplish the purposes of the HMFA Law.

11. This Agreement may be executed in any number of counterparts, each of which shall be deemed an original, but all of which together shall constitute one and the same agreement. It shall not be necessary in making proof of this Agreement to produce or account for more than a sufficient number of counterparts to evidence the execution of the Agreement by each party hereto.

It is expressly understood and agreed that the revenue projections provided to the City as set forth in Exhibit "A" and as part of the Sponsor's application for an agreement for payments in lieu of taxes are estimates only. The actual payments in lieu of taxes to be paid by the Sponsor shall be determined pursuant to Section 5 below.

5. (a) Payments by the Sponsor shall be made on a quarterly basis in accordance with bills issued by the Tax Collector of the City in the same manner and on the same dates as real estate taxes are paid to the City and shall be based upon Project Revenues of the previous quarter. No later than three (3) months following the end of the first fiscal year of operation after (i) the date of Substantial Completion (for projects receiving construction and permanent financing) or (ii) the date of the Agency Mortgage (for projects receiving permanent financing only) and each year thereafter that this Agreement remains in effect, the Sponsor shall submit to the City a certified, audited financial statement of the operation of the Project (the "Audit"), setting forth the Project Revenues and the total payments in lieu of taxes due to the City calculated at seven point eight (7.80%) of Project Revenues as set forth in the Audit (the "Audit Amount"). The Sponsor simultaneously shall pay the difference, if any, between (i) the Audit Amount and (ii) payments made by the Sponsor to the City for the preceding fiscal year. The City may accept any such payment without prejudice to its right to challenge the amount due. In the event that the payments made by the Sponsor for any fiscal year shall exceed the Audit Amount for such fiscal year, the City shall credit the amount of such excess to the account of the Sponsor.

(b) All payments pursuant to this Agreement shall be in lieu of taxes and the City shall have all the rights and remedies of tax enforcement granted to Municipalities by law just as if said payments constituted regular tax obligations on real property within the City. If, however, the City disputes the total amount of the annual payment in lieu of taxes due it, based upon the Audit, it may apply to the Superior Court, Chancery Division for an accounting of the service charge due the City, in accordance with this Agreement and HMFA Law. Any such action must be commenced within one year of the receipt of the Audit by the City.

(c) In the event of any delinquency in the aforesaid payments, the City shall give notice to the Sponsor and NJHMFA in the manner set forth in 9(a) below, prior to any legal action being taken.

6. The tax exemption provided herein shall apply only so long as the Sponsor or its successors and assigns and the Project remain subject to the provisions of the HMFA Law and Regulations made thereunder and the supervision of the Agency, but in no event longer than the term of the Agency Mortgage unless extended by the City pursuant to Section 37 c. of the HMFA Law. In the event of (a) a sale, transfer or conveyance of the Project by the Sponsor or (b) a change in the organizational structure of the Sponsor, this Agreement shall be assigned to the Sponsor's successor and shall continue in full force and effect so long as the successor entity qualifies under the HMFA Law or any other state law applicable at the time of the assignment of this Agreement and assumes the Agency Mortgage.

7. Upon any termination of such tax exemption, whether by affirmative action of the Sponsor, its successors and assigns, or by virtue of the provisions of the HMFA Law, or any other applicable state law, the Project shall be taxed as omitted property in accordance with the law.

8. The Sponsor, its successors and assigns shall, upon request, permit inspection of property, equipment, buildings and other facilities of the Project and also documents and papers by representatives duly authorized by the City. Any such inspection, examination or audit shall be made during reasonable hours of the business day, in the presence of an officer or agent of the Sponsor or its successors and assigns.

9. Any notice or communication sent by either party to the other hereunder shall be sent by certified mail, return receipt requested, addressed as follows:

(a) When sent by the City to the Sponsor, it shall be addressed to 100 Henry Street, Brooklyn, New York 11201 or to such other address as the Sponsor may hereafter designate in writing and a copy of said notice or communication by the City to the Sponsor shall be sent by the City to the New Jersey Housing and Mortgage Finance Agency, 637 South Clinton Avenue, P.O. Box 18550, Trenton, New Jersey 08650-2085.

(b) When sent by the Sponsor to the City, it shall be addressed to the Municipal Clerk, 520 Market Street, City Hall, Room 105, Camden, New Jersey 08102 or to such other address as the City may designate in writing; and a copy of said notice or communication by the Sponsor to the City shall be sent by the Sponsor to the New Jersey Housing and Mortgage Finance Agency, 637 South Clinton Avenue, P.O. Box 18550, Trenton, New Jersey 08650-2085.

10. In the event of a breach of this Agreement by either of the parties hereto or a dispute arising between the parties in reference to the terms and provisions as set forth herein, either party may apply to the Superior Court, Chancery Division, to settle and resolve said dispute in such fashion as will tend to accomplish the purposes of the HMFA Law.

11. This Agreement may be executed in any number of counterparts, each of which shall be deemed an original, but all of which together shall constitute one and the same agreement. It shall not be necessary in making proof of this Agreement to produce or account for more than a sufficient number of counterparts to evidence the execution of the Agreement by each party hereto.

## AGREEMENT FOR PAYMENT IN LIEU OF TAXES

THIS AGREEMENT, made this \_\_\_\_\_ day of \_\_\_\_\_, 2025, between Camden Heights LLC, having an office at 100 Henry Street, Brooklyn, New York 11201 (hereinafter the "Sponsor") and the City of Camden, a municipal corporation in the County of Camden and State of New Jersey (hereinafter the "City").

### WITNESSETH

In consideration of the mutual covenants herein contained and for other good and valuable consideration, it is mutually covenanted and agreed as follows:

1. This Agreement is made pursuant to the authority contained in Section 37 of the New Jersey Housing and Mortgage Finance Agency Law of 1983 (N.J.S.A. 55:14K-1 et seq.) (hereinafter "HMFA Law") and a Resolution of the City Council duly adopted on \_\_\_\_\_, 2025, (the "Resolution") and with the approval of the New Jersey Housing and Mortgage Finance Agency (hereinafter the "Agency"), as required by N.J.S.A. 55:14K-37.

2. The Project is or will be situated on that parcel of land designated as Block 569, Lot 1 and Block 547, Lot 62, as shown on the Official Assessment Map of the City of Camden, and more commonly referred to as 1936 South 8<sup>th</sup> Street, Camden, New Jersey 08104, and currently known as "All American Garden Apartments."

3. As of the date the Sponsor executes a first mortgage upon the Project in favor of the Agency (hereinafter referred to as the "Agency Mortgage"), the land and improvements comprising the Project shall be exempt from real property taxes, provided that the Sponsor shall make payments in lieu of taxes to the City as provided hereinafter. AGREEMENT FOR PAYMENT IN LIEU OF TAXES

THIS AGREEMENT, made this \_\_\_\_ day of \_\_\_\_\_, 2025, between Camden Heights LLC, having an office at 100 Henry Street, Brooklyn, New York 11201 (hereinafter the "Sponsor") and the City of Camden, a municipal corporation in the County of Camden and State of New Jersey (hereinafter the "City").

WITNESSETH

In consideration of the mutual covenants herein contained and for other good and valuable consideration, it is mutually covenanted and agreed as follows:

1. This Agreement is made pursuant to the authority contained in Section 37 of the New Jersey Housing and Mortgage Finance Agency Law of 1983 (N.J.S.A. 55:14K-1 et seq.) (hereinafter "HMFA Law") and a Resolution of the City Council duly adopted on \_\_\_\_\_, 2025, (the "Resolution") and with the approval of the New Jersey Housing and Mortgage Finance Agency (hereinafter the "Agency"), as required by N.J.S.A. 55:14K-37.

2. The Project is or will be situated on that parcel of land designated as Block 1095, Lot 1, Block 1095, Lot 29, Block 1096, Lot 8, and Block 1099, Lot 33 as shown on the Official Assessment Map of the City of Camden, and more commonly referred to as 2805 Mitchell Street, Camden, New Jersey 08105, and currently known as "Macedonia Garden Apartments."

3. As of the date the Sponsor executes a first mortgage upon the Project in favor of the Agency (hereinafter referred to as the "Agency Mortgage"), the land and improvements comprising the Project shall be exempt from real property taxes, provided that the Sponsor shall make payments in lieu of taxes to the City as provided hereinafter. Except as set forth in Section 6 of this Agreement the exemption of the Project from real property taxation and the sponsor's obligation to make payments in lieu of taxes shall not extend beyond the date on which the Agency Mortgage is paid in full, which, according to the HMFA Law, may not exceed fifty (50) years.

4. (a) For projects receiving construction and permanent financing from the Agency, the Sponsor shall make payment to the City of an annual service charge in lieu of taxes in such amount as follows:

- (1) From the date of the execution of the Agency Mortgage until the date of Substantial Completion of the Project, the Sponsor shall make payment to the City in the amount equal to the current real estate taxes (pursuant to the HMFA Law, the annual amount may not exceed the amount of taxes due on the property for the year preceding the recording of the Agency Mortgage). As used herein, "Substantial Completion" means the date upon which the City issues the Certificate of Occupancy for all of the units in the Project.
- (2) From the date of Substantial Completion of the Project and for the remaining term of the NJHMFA Mortgage, the Sponsor shall make payment to the City

in an amount equal to seven point eight (7.8%) of Project Revenues.

(b) For Projects receiving permanent financing only from the Agency, the Sponsor shall make payment to the City in an amount equal to seven point eight (7.8%) of Project Revenues from the date of the Agency Mortgage and for the remaining term of the Agency Mortgage.

(c) As used herein, "Project Revenues" means the total annual gross rental or carrying charge or other income of the Sponsor from the Project less the costs of utilities furnished by the Project, which shall include the costs of gas, electricity, heating fuel, water supplied, and sewage charges, and less vacancies if any. Project Revenues shall not include any rental subsidy contributions received from any federal or state program.

(d) The amount of payment in lieu of taxes to be paid pursuant to paragraphs (a) or (b) and (c) above is calculated in Exhibit "A" attached hereto. It is expressly understood and agreed that the revenue projections provided to the City as set forth in Exhibit "A" and as part of the Sponsor's application for an agreement for payments in lieu of taxes are estimates only. The actual payments in lieu of taxes to be paid by the Sponsor shall be determined pursuant to Section 5 below.

5. (a) Payments by the Sponsor shall be made on a quarterly basis in accordance with bills issued by the Tax Collector of the City in the same manner and on the same dates as real estate taxes are paid to the City and shall be based upon Project Revenues of the previous quarter. No later than three (3) months following the end of the first fiscal year of operation after (i) the date of Substantial Completion (for projects receiving construction and permanent financing) or (ii) the date of the Agency Mortgage (for projects receiving permanent financing only) and each year thereafter that this Agreement remains in effect, the Sponsor shall submit to the City a certified, audited financial statement of the operation of the Project (the "Audit"), setting forth the Project Revenues and the total payments in lieu of taxes due to the City calculated at seven point eight (7.8%) of Project Revenues as set forth in the Audit (the "Audit Amount"). The Sponsor simultaneously shall pay the difference, if any, between (i) the Audit Amount and (ii) payments made by the Sponsor to the City for the preceding fiscal year. The City may accept any such payment without prejudice to its right to challenge the amount due. In the event that the payments made by the Sponsor for any fiscal year shall exceed the Audit Amount for such fiscal year, the City shall credit the amount of such excess to the account of the Sponsor.

(b) All payments pursuant to this Agreement shall be in lieu of taxes and the City shall have all the rights and remedies of tax enforcement granted to Municipalities by law just as if said payments constituted regular tax obligations on real property within the City. If, however, the City disputes the total amount of the annual payment in lieu of taxes due it, based upon the Audit, it may apply to the Superior Court, Chancery Division for an accounting of the service charge due the City, in accordance with this Agreement and HMFA Law. Any such action must be commenced within one year of the receipt of the Audit by the City.

(c) In the event of any delinquency in the aforesaid payments, the City shall give notice to the Sponsor and NJHMFA in the manner set forth in 9(a) below, prior to any legal action being taken.

6. The tax exemption provided herein shall apply only so long as the Sponsor or its successors and assigns and the Project remain subject to the provisions of the HMFA Law and Regulations made thereunder and the supervision of the Agency, but in no event longer than the term of the Agency Mortgage unless extended by the City pursuant to Section 37 c. of the HMFA Law. In the event of (a) a sale, transfer or conveyance of the Project by the Sponsor or (b) a change in the organizational structure of the Sponsor, this Agreement shall be assigned to the Sponsor's successor and shall continue in full force and effect so long as the successor entity qualifies under the HMFA Law or any other state law applicable at the time of the assignment of this Agreement and assumes the Agency Mortgage.

7. Upon any termination of such tax exemption, whether by affirmative action of the Sponsor, its successors and assigns, or by virtue of the provisions of the HMFA Law, or any other applicable state law, the Project shall be taxed as omitted property in accordance with the law.

8. The Sponsor, its successors and assigns shall, upon request, permit inspection of property, equipment, buildings and other facilities of the Project and also documents and papers by representatives duly authorized by the City. Any such inspection, examination or audit shall be made during reasonable hours of the business day, in the presence of an officer or agent of the Sponsor or its successors and assigns.

9. Any notice or communication sent by either party to the other hereunder shall be sent by certified mail, return receipt requested, addressed as follows:

(a) When sent by the City to the Sponsor, it shall be addressed to 100 Henry Street, Brooklyn, New York 11201 or to such other address as the Sponsor may hereafter designate in writing and a copy of said notice or communication by the City to the Sponsor shall be sent by the City to the New Jersey Housing and Mortgage Finance Agency, 637 South Clinton Avenue, P.O. Box 18550, Trenton, New Jersey 08650-2085.

(b) When sent by the Sponsor to the City, it shall be addressed to the Municipal Clerk, 520 Market Street, City Hall, Room 105, Camden, New Jersey 08102 or to such other address as the City may designate in writing; and a copy of said notice or communication by the Sponsor to the City shall be sent by the Sponsor to the New Jersey Housing and Mortgage Finance Agency, 637 South Clinton Avenue, P.O. Box 18550, Trenton, New Jersey 08650-2085.

10. In the event of a breach of this Agreement by either of the parties hereto or a dispute arising between the parties in reference to the terms and provisions as set forth herein, either party may apply to the Superior Court, Chancery Division, to settle and resolve said dispute in such fashion as will tend to accomplish the purposes of the HMFA Law.

11. This Agreement may be executed in any number of counterparts, each of which shall be deemed an original, but all of which together shall constitute one and the same agreement. **AGREEMENT FOR PAYMENT IN LIEU OF TAXES**

THIS AGREEMENT, made this \_\_\_\_\_ day of \_\_\_\_\_, 2025, between Camden Heights LLC, having an office at 100 Henry Street, Brooklyn, New York 11201 (hereinafter the "Sponsor") and the City of Camden, a municipal corporation in the County of Camden and State of New Jersey (hereinafter the "City").

**WITNESSETH**

In consideration of the mutual covenants herein contained and for other good and valuable consideration, it is mutually covenanted and agreed as follows:

1. This Agreement is made pursuant to the authority contained in Section 37 of the New Jersey Housing and Mortgage Finance Agency Law of 1983 (N.J.S.A. 55:14K-1 et seq.) (hereinafter "HMFA Law") and a Resolution of the City Council duly adopted on \_\_\_\_\_, 2025, (the "Resolution") and with the approval of the New Jersey Housing and Mortgage Finance Agency (hereinafter the "Agency"), as required by N.J.S.A. 55:14K-37.

2. The Project is or will be situated on that parcel of land designated as Block 555, Lot 3, Block 552, Lot 6, Block 555, Lot 35, and Block 555, Lot 60 as shown on the Official Assessment Map of the City of Camden, and more commonly referred to as 1008 Central Avenue, Camden, New Jersey 08104, and currently known as "J. Allen Nimmo Apartments."

3. As of the date the Sponsor executes a first mortgage upon the Project in favor of the Agency (hereinafter referred to as the "Agency Mortgage"), the land and improvements comprising the Project shall be exempt from real property taxes, provided that the Sponsor shall make payments in lieu of taxes to the City as provided hereinafter. Except as set forth in Section 6 of this Agreement the exemption of the Project from real property taxation and the sponsor's obligation to make payments in lieu of taxes shall not extend beyond the date on which the Agency Mortgage is paid in full, which, according to the HMFA Law, may not exceed fifty (50) years.

4. (a) For projects receiving construction and permanent financing from the Agency, the Sponsor shall make payment to the City of an annual service charge in lieu of taxes in such amount as follows:

(1) From the date of the execution of the Agency Mortgage until the date of Substantial Completion of the Project, the Sponsor shall make payment to the City in the amount equal to the current real estate taxes (pursuant to the HMFA Law, the annual amount may not exceed the amount of taxes due on the property for the year preceding the recording of the Agency Mortgage). As used herein, "Substantial Completion" means the date upon which the City issues the Certificate of Occupancy for all of the units in the Project.

(2) From the date of Substantial Completion of the Project and for the remaining

term of the NJHMFA Mortgage, the Sponsor shall make payment to the City in an amount equal to seven point eight (7.8%) of Project Revenues.

(b) For Projects receiving permanent financing only from the Agency, the Sponsor shall make payment to the City in an amount equal to seven point eight (7.8%) of Project Revenues from the date of the Agency Mortgage and for the remaining term of the Agency Mortgage.

(c) As used herein, "Project Revenues" means the total annual gross rental or carrying charge or other income of the Sponsor from the Project less the costs of utilities furnished by the Project, which shall include the costs of gas, electricity, heating fuel, water supplied, and sewage charges, and less vacancies if any. Project Revenues shall not include any rental subsidy contributions received from any federal or state program.

(d) The amount of payment in lieu of taxes to be paid pursuant to paragraphs (a) or (b) and (c) above is calculated in Exhibit "A" attached hereto. It is expressly understood and agreed that the revenue projections provided to the City as set forth in Exhibit "A" and as part of the Sponsor's application for an agreement for payments in lieu of taxes are estimates only. The actual payments in lieu of taxes to be paid by the Sponsor shall be determined pursuant to Section 5 below.

5. (a) Payments by the Sponsor shall be made on a quarterly basis in accordance with bills issued by the Tax Collector of the City in the same manner and on the same dates as real estate taxes are paid to the City and shall be based upon Project Revenues of the previous quarter. No later than three (3) months following the end of the first fiscal year of operation after (i) the date of Substantial Completion (for projects receiving construction and permanent financing) or (ii) the date of the Agency Mortgage (for projects receiving permanent financing only) and each year thereafter that this Agreement remains in effect, the Sponsor shall submit to the City a certified, audited financial statement of the operation of the Project (the "Audit"), setting forth the Project Revenues and the total payments in lieu of taxes due to the City calculated at seven point eight (7.8%) of Project Revenues as set forth in the Audit (the "Audit Amount"). The Sponsor simultaneously shall pay the difference, if any, between (i) the Audit Amount and (ii) payments made by the Sponsor to the City for the preceding fiscal year. The City may accept any such payment without prejudice to its right to challenge the amount due. In the event that the payments made by the Sponsor for any fiscal year shall exceed the Audit Amount for such fiscal year, the City shall credit the amount of such excess to the account of the Sponsor.

(b) All payments pursuant to this Agreement shall be in lieu of taxes and the City shall have all the rights and remedies of tax enforcement granted to Municipalities by law just as if said payments constituted regular tax obligations on real property within the City. If, however, the City disputes the total amount of the annual payment in lieu of taxes due it, based upon the Audit, it may apply to the Superior Court, Chancery Division for an accounting of the service charge due the City, in accordance with this Agreement and HMFA Law. Any such action must be commenced within one year of the receipt of the Audit by the City.

(c) In the event of any delinquency in the aforesaid payments, the City shall give notice to the Sponsor and NJHMFA in the manner set forth in 9(a) below, prior to any legal action being taken.

6. The tax exemption provided herein shall apply only so long as the Sponsor or its successors and assigns and the Project remain subject to the provisions of the HMFA Law and Regulations made thereunder and the supervision of the Agency, but in no event longer than the term of the Agency Mortgage unless extended by the City pursuant to Section 37 c. of the HMFA Law. In the event of (a) a sale, transfer or conveyance of the Project by the Sponsor or (b) a change in the organizational structure of the Sponsor, this Agreement shall be assigned to the Sponsor's successor and shall continue in full force and effect so long as the successor entity qualifies under the HMFA Law or any other state law applicable at the time of the assignment of this Agreement and assumes the Agency Mortgage.

7. Upon any termination of such tax exemption, whether by affirmative action of the Sponsor, its successors and assigns, or by virtue of the provisions of the HMFA Law, or any other applicable state law, the Project shall be taxed as omitted property in accordance with the law.

8. The Sponsor, its successors and assigns shall, upon request, permit inspection of property, equipment, buildings and other facilities of the Project and also documents and papers by representatives duly authorized by the City. Any such inspection, examination or audit shall be made during reasonable hours of the business day, in the presence of an officer or agent of the Sponsor or its successors and assigns.

9. Any notice or communication sent by either party to the other hereunder shall be sent by certified mail, return receipt requested, addressed as follows:

(a) When sent by the City to the Sponsor, it shall be addressed to 100 Henry Street, Brooklyn, New York 11201 or to such other address as the Sponsor may hereafter designate in writing and a copy of said notice or communication by the City to the Sponsor shall be sent by the City to the New Jersey Housing and Mortgage Finance Agency, 637 South Clinton Avenue, P.O. Box 18550, Trenton, New Jersey 08650-2085.

(b) When sent by the Sponsor to the City, it shall be addressed to the Municipal Clerk, 520 Market Street, City Hall, Room 105, Camden, New Jersey 08102 or to such other address as the City may designate in writing; and a copy of said notice or communication by the Sponsor to the City shall be sent by the Sponsor to the New Jersey Housing and Mortgage Finance Agency, 637 South Clinton Avenue, P.O. Box 18550, Trenton, New Jersey 08650-2085.

10. In the event of a breach of this Agreement by either of the parties hereto or a dispute arising between the parties in reference to the terms and provisions as set forth herein, either party may apply to the Superior Court, Chancery Division, to settle and resolve said dispute in such fashion as will tend to accomplish the purposes of the HMFA Law.

11. This Agreement may be executed in any number of counterparts, each of which shall be deemed an original, but all of which together shall constitute one and the same agreement. It shall not be necessary in making proof of this Agreement to produce or account for more than a sufficient number of counterparts to evidence the execution of the Agreement by each party hereto.

(b) For Projects receiving permanent financing only from the Agency, the Sponsor shall make payment to the City in an amount equal to six point twenty-eight (6.28%) of Project Revenues from the date of the Agency Mortgage and for the remaining term of the Agency Mortgage.

(c) As used herein, "Project Revenues" means the total annual gross rental or carrying charge or other income of the Sponsor from the Project less the costs of utilities furnished by the Project, which shall include the costs of gas, electricity, heating fuel, water supplied, and sewage charges, and less vacancies if any. Project Revenues shall not include any rental subsidy contributions received from any federal or state program.

(d) The amount of payment in lieu of taxes to be paid pursuant to paragraphs (a) or (b) and (c) above is calculated in Exhibit "A" attached hereto. It is expressly understood and agreed that the revenue projections provided to the City as set forth in Exhibit "A" and as part of the Sponsor's application for an agreement for payments in lieu of taxes are estimates only. The actual payments in lieu of taxes to be paid by the Sponsor shall be determined pursuant to Section 5 below.

5. (a) Payments by the Sponsor shall be made on a quarterly basis in accordance with bills issued by the Tax Collector of the City in the same manner and on the same dates as real estate taxes are paid to the City and shall be based upon Project Revenues of the previous quarter. No later than three (3) months following the end of the first fiscal year of operation after (i) the date of Substantial Completion (for projects receiving construction and permanent financing) or (ii) the date of the Agency Mortgage (for projects receiving permanent financing only) and each year thereafter that this Agreement remains in effect, the Sponsor shall submit to the City a certified, audited financial statement of the operation of the Project (the "Audit"), setting forth the Project Revenues and the total payments in lieu of taxes due to the City calculated at six point twenty-eight (6.28%) of Project Revenues as set forth in the Audit (the "Audit Amount"). The Sponsor simultaneously shall pay the difference, if any, between (i) the Audit Amount and (ii) payments made by the Sponsor to the City for the preceding fiscal year. The City may accept any such payment without prejudice to its right to challenge the amount due. In the event that the payments made by the Sponsor for any fiscal year shall exceed the Audit Amount for such fiscal year, the City shall credit the amount of such excess to the account of the Sponsor.

(b) All payments pursuant to this Agreement shall be in lieu of taxes and the City shall have all the rights and remedies of tax enforcement granted to Municipalities by law just as if said payments constituted regular tax obligations on real property within the City. If, however, the City disputes the total amount of the annual payment in lieu of taxes due it, based upon the Audit, it may apply to the Superior Court, Chancery Division for an accounting of the service charge due the City, in accordance with this Agreement and HMFA Law. Any such action must be commenced within one year of the receipt of the Audit by the City.

(c) In the event of any delinquency in the aforesaid payments, the City shall give notice to the Sponsor and NJHMFA in the manner set forth in 9(a) below, prior to any legal action being taken.

6. The tax exemption provided herein shall apply only so long as the Sponsor or its successors and assigns and the Project remain subject to the provisions of the HMFA Law and Regulations made thereunder and the supervision of the Agency, but in no event longer than the term of the Agency Mortgage unless extended by the City pursuant to Section 37 c. of the HMFA Law. In the event of (a) a sale, transfer or conveyance of the Project by the Sponsor or (b) a change in the organizational structure of the Sponsor, this Agreement shall be assigned to the Sponsor's successor and shall continue in full force and effect so long as the successor entity qualifies under the HMFA Law or any other state law applicable at the time of the assignment of this Agreement and assumes the Agency Mortgage.

7. Upon any termination of such tax exemption, whether by affirmative action of the Sponsor, its successors and assigns, or by virtue of the provisions of the HMFA Law, or any other applicable state law, the Project shall be taxed as omitted property in accordance with the law.

8. The Sponsor, its successors and assigns shall, upon request, permit inspection of property, equipment, buildings and other facilities of the Project and also documents and papers by representatives duly authorized by the City. Any such inspection, examination or audit shall be made during reasonable hours of the business day, in the presence of an officer or agent of the Sponsor or its successors and assigns.

9. Any notice or communication sent by either party to the other hereunder shall be sent by certified mail, return receipt requested, addressed as follows:

(a) When sent by the City to the Sponsor, it shall be addressed to 100 Henry Street, Brooklyn, New York 11201 or to such other address as the Sponsor may hereafter designate in writing and a copy of said notice or communication by the City to the Sponsor shall be sent by the City to the New Jersey Housing and Mortgage Finance Agency, 637 South Clinton Avenue, P.O. Box 18550, Trenton, New Jersey 08650-2085.

(b) When sent by the Sponsor to the City, it shall be addressed to the Municipal Clerk, 520 Market Street, City Hall, Room 105, Camden, New Jersey 08102 or to such other address as the City may designate in writing; and a copy of said notice or communication by the Sponsor to the City shall be sent by the Sponsor to the New Jersey Housing and Mortgage Finance Agency, 637 South Clinton Avenue, P.O. Box 18550, Trenton, New Jersey 08650-2085.

10. In the event of a breach of this Agreement by either of the parties hereto or a dispute arising between the parties in reference to the terms and provisions as set forth herein, either party may apply to the Superior Court, Chancery Division, to settle and resolve said dispute in such fashion as will tend to accomplish the purposes of the HMFA Law.

11. This Agreement may be executed in any number of counterparts, each of which shall be deemed an original, but all of which together shall constitute one and the same agreement. It shall not be necessary in making proof of this Agreement to produce or account for more than a sufficient number of counterparts to evidence the execution of the Agreement by each party hereto.

As you are aware, our office was awarded a contract (No. 10-23-058) from the City for several roadway improvement projects. The projects encompassed the following:

- 2023 Roadway Improvement Program (Contract #1)
- 2023 Roadway Improvement Program (Contract #2)
- Resurfacing of Cooper Street (Design Only)
- 2024 Roadway Improvement Program (Contract #1) (Design Only)
- 2024 Roadway Improvement Program (Contract #2) (Design Only)
- FY\* 2023 NJDOT Local Aid Pedestrian Safety Improvements (Design Only)

At the time of proposal submission and authorization for the 2023 Roadway Improvement Program (Contract #1 & Contract #2), our proposal provided for part-time construction observation for these two (2) projects. However, once construction contracts were awarded, our office was notified that full-time construction observation would be required for the projects.

In lieu of requesting additional compensation at that time, our office attempted to absorb the cost for additional work efforts within the 2023 Road Improvement Programs (Contract #1 & #2). Unfortunately, due to the following circumstances, our office was unable to absorb the additional work efforts within the original budget(s):

- As you are aware, the City requested the field design & construction oversight for the resurfacing of 3<sup>rd</sup> Street (from Clinton St. to Federal Street) in Ward 1.
- As you are aware, the City requested the field design & construction oversight for the resurfacing of Independence Road (from Alabama Road to Alabama Road) in Ward 1.
- During construction, there were multiple roadways that were affected by work performed by PSE&G for their gas main replacement and resurfacing project. This required extensive coordination with PSE&G, the contractor(s), and the City for adjustment of roadway improvement limits, installation / modification of ADA curb ramps and storm inlet replacement.

Additionally, supplemental construction observation & contract administration was required due to construction contract time extensions due to various reasons such as; weather delays, material delays, additional construction work added to the contract, and scheduling conflicts with PSE&G as detailed below:

- Additional construction oversight & contract administration for time extensions for 2023 Roadway Improvement Program (Contract #1) from one-hundred and twenty (120) calendar days to two-hundred and fifty-five (255) calendar days.
- Additional construction oversight & contract administration for time extensions for 2023 Roadway Improvement Program (Contract #2) from one-hundred and twenty (120) calendar days to two-hundred and forty-five (245) calendar days.

The FY' 2024 Roadway Improvement Program Contract #1 incurred additional field survey and base plan preparation costs that were unforeseen at the time of the proposal. During our field survey efforts, we encountered multiple unanticipated conditions that extended the scope of work. In particular, the older infrastructure and incomplete utility records from the City required additional field verification and coordination. In addition, extra traffic control measures and personnel were required for numerous roadways to ensure public safety.

The FY' 2023 Pedestrian Safety Improvements Program design also incurred additional design efforts that were not in the original scope of work for the project. At the time of proposal submission and authorization for the FY' 2023 NJDOT Local Aid Pedestrian Safety Improvements program, the City took no exception to the estimated construction cost for the project in the amount of \$5,663,330.00. However, our office was requested by the City to modify the design to reduce project costs, and to include alternate bids as a contingency to avoid surpassing the grant allotment, including reimbursable professional services fees. The revised engineer's estimate is approximately \$4,456,200.22.

Additionally, our office was required to modify the scope of the project in coordination with the NJDOT and the City's Capital Improvements office. Our office was instructed to:

- Remove the design for the intersection of Linden Street and 7th Street
- Remove the design for the intersection of Linden Street and 8th Street
- Remove the design for Wayne Avenue (from 27th Street to 28th Street)
- Add the design of the intersection of 8th Street and Carl Miller Boulevard.

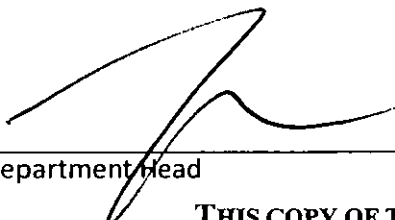

Additionally, supplemental construction observation & contract administration was required due to construction contract time extensions due to various reasons such as; weather delays, material delays, additional construction work added to the contract, and scheduling conflicts with PSE&G as detailed below:

- Additional construction oversight & contract administration for time extensions for 2023 Roadway Improvement Program (Contract #1) from one-hundred and twenty (120) calendar days to two-hundred and fifty-five (255) calendar days.
- Additional construction oversight & contract administration for time extensions for 2023 Roadway Improvement Program (Contract #2) from one-hundred and twenty (120) calendar days to two-hundred and forty-five (245) calendar days.

The FY' 2024 Roadway Improvement Program Contract #1 incurred additional field survey and base plan preparation costs that were unforeseen at the time of the proposal. During our field survey efforts, we encountered multiple unanticipated conditions that extended the scope of work. In particular, the older infrastructure and incomplete utility records from the City required additional field verification and coordination. In addition, extra traffic control measures and personnel were required for numerous roadways to ensure public safety.

The FY' 2023 Pedestrian Safety Improvements Program design also incurred additional design efforts that were not in the original scope of work for the project. At the time of proposal submission and authorization for the FY' 2023 NJDOT Local Aid Pedestrian Safety Improvements program, the City took no exception to the estimated construction cost for the project in the amount of \$5,663,330.00. However, our office was requested by the City to modify the design to reduce project costs, and to include alternate bids as a contingency to avoid surpassing the grant allotment, including reimbursable professional services fees. The revised engineer's estimate is approximately \$4,456,200.22.

Additionally, our office was required to modify the scope of the project in coordination with the NJDOT and the City's Capital Improvements office. Our office was instructed to:

- Remove the design for the intersection of Linden Street and 7th Street
- Remove the design for the intersection of Linden Street and 8th Street
- Remove the design for Wayne Avenue (from 27th Street to 28th Street)
- Add the design of the intersection of 8th Street and Carl Miller Boulevard.

As you are aware, our office was awarded a contract (No. 10-23-058) from the City for several roadway improvement projects. The projects encompassed the following:

- Resurfacing of Cooper Street (Design Only)
- 2024 Roadway Improvement Program (Contract #1) (Design Only)
- 2024 Roadway Improvement Program (Contract #2) (Design Only)
- FY\* 2023 NJDOT Local Aid Pedestrian Safety Improvements (Design Only)

At the time of proposal submission and authorization for the 2023 Roadway Improvement Program (Contract #1 & Contract #2), our proposal provided for part-time construction observation for these two (2) projects. However, once construction contracts were awarded, our office was notified that full-time construction observation would be required for the projects.

In lieu of requesting additional compensation at that time, our office attempted to absorb the cost for additional work efforts within the 2023 Road Improvement Programs (Contract #1 & #2). Unfortunately, due to the following circumstances, our office was unable to absorb the additional work efforts within the original budget(s):

- As you are aware, the City requested the field design & construction oversight for the resurfacing of 3<sup>rd</sup> Street (from Clinton St. to Federal Street) in Ward 1.
- As you are aware, the City requested the field design & construction oversight for the resurfacing of Independence Road (from Alabama Road to Alabama Road) in Ward 1.
- During construction, there were multiple roadways that were affected by work performed by PSE&G for their gas main replacement and resurfacing project. This required extensive coordination with PSE&G, the contractor(s), and the City for adjustment of roadway improvement limits, installation / modification of ADA curb ramps and storm inlet replacement.

  - N 10th Street (from Linden Street to Penn Street)
2. Curb Ramp and Traffic Signalization Upgrades:
  - Intersection of Linden Street and N 9th Street
  - Intersection of Linden Street and N 10<sup>th</sup> Street
  - Intersection of Linden Street and N 11<sup>th</sup> Street
3. Curb, Sidewalk, ADA Improvements and Roadway Resurfacing:
  - 8th Street (from Carl Miller Blvd to Atlantic Ave)
  - Grand Avenue (from Baird St (C.R. 608) to Berkley St)
  - 29th Street (from River Rd to Adams Ave)
  - Midvale Avenue (from Marlton Pike (C.R. 601) to Rand St)
  - Elm Street (from 7th St to 10th St)
  - Everett Street (from S 10th St to Mt Ephraim Avenue (C.R. 605))
  - Friends St (from Pearl St to Penn St) – Alternate No. 1
  - Line Street (from 9th St to Newton Ave (C.R. 604)) – Alternate No. 2

Proposed improvements consist of, but are not limited to, the following major work items as noted above:

- Replacement of concrete vertical curb, sidewalk and driveway aprons within project limits.
- Installation of ADA compliant curb ramps.
- Pedestrian safety improvements to existing traffic signals, where needed.
- Resurfacing of the roadways.
- Installation of stormwater drainage infrastructure, where needed.

As you are aware, the New Jersey Department of Transportation (NJDOT) has awarded \$5,000,000.00 to the City of Camden for the FY 2023 Pedestrian Safety Improvements Program. The estimated construction cost for the project is \$4,453,975.00.

The following two (2) phased approach will be utilized for the professional services associated with the project.

#### **PHASE I: CONSTRUCTION OBSERVATION**

This phase consists of the professional services and tasks required after the project is formally awarded by the City for the construction phase of the project. Work efforts during this phase shall include, but are not necessarily limited to, the following major work items/tasks based on an anticipated two hundred and seventy (270) day contract completion time:

- Coordinate and conduct the pre-construction meeting and prepare and distribute meeting minutes.
- Issue the Notice to Proceed, review construction schedule, and review of all required shop drawings and submittals.
- Perform field observation/inspection services on a full-time basis. RVE will provide qualified construction observers during normal working hours, during critical aspects of construction.

#### **PHASE II: CONTRACT ADMINISTRATION**

This phase consists of the following work items/tasks:

- Prepare and/or coordinate the execution and distribution of the construction contract documents to the successful bidder, and the City.
- Review, prepare, and submit payment recommendations for the contractor to the City.

#### ***Project Closeout Documentation and Submission to the NJDOT***

Upon completion of construction activities, our office will coordinate and compile all required closeout documentation in accordance with NJDOT standards. This task includes the preparation and submission of hard copies of various required forms and certifications such as Final Payment Vouchers, Completion Certificates, Change Orders, DBE Participation Reports, Materials Certifications, and any necessary contractor affidavits. These documents will be carefully reviewed for completeness and accuracy prior to submission, ensuring timely NJDOT acceptance and reimbursement. All forms will be submitted as physical copies in accordance with NJDOT closeout requirements for this project.

#### **SPECIFIC EXCLUSIONS**

The following work items are specifically excluded:

- Preparation of applications for review/regulatory agencies not specifically indicated.
- Application fees for review and/or permits from regulatory agencies.
- Right-of-way acquisition & construction easement documents.
- Testing of construction materials
- Contract administration & construction observation services required in excess of the estimated two hundred and seventy (270) day contract time.

If unforeseen and/or unanticipated work items arise, or if Alternates No. 1 & 2 are not awarded, our office can provide a separate scope of services & cost proposal for consideration and approval by the City.

**COST OF SERVICES:**

Our fee for these efforts shall not exceed \$342,990.00, which will be billed monthly on a lump sum basis based on percentage complete of each phase:

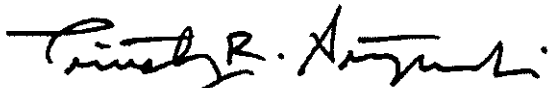

**SECTION 2 - TERMS OF PAYMENT.** Monthly payment for the Services shall be included in Customer's bill. Upfront payments for the Services as identified in the Form of Proposal is required before the start of work, unless otherwise indicated.

### SECTION 3 - WARRANTY AND REMEDIES

A. PSEG warrants that for the period of twelve (12) months after the completion of the Services, the Services will reflect competent professional knowledge, judgment and workmanship and will be performed in accordance with generally accepted professional standards and work practices applicable at the time the Services are performed. PSEG warrants that any goods (e.g. lights, brackets and poles) installed shall be free from defects in material or workmanship for one year from the date of installation or provision, whichever occurs first.

B. PSEG does not warrant and shall have no liability for any nonconformance or defects in the performance of the finish on painted street lighting equipment. Customer shall pursue all claims for nonconformance or defects in the performance of the finish on painted street lighting equipment against the manufacturer and PSEG shall take commercially reasonable efforts to support and assist Customer.

C. Conditions Applying to Warranties.

1. PSEG shall have no liability or obligation for any manufacturing, construction or design defects in the Customer's facilities and equipment, hidden hazardous conditions, or the Customer's failure to comply with all applicable codes, standards, laws, and regulations.
2. Customer shall provide PSEG with any pertinent facts or information concerning the Customer's facilities and equipment which could affect the Services to be performed therein which are known or accessible only to the Customer or not reasonably discoverable by PSEG.
3. Customer will provide written notice to PSEG specifying nonconforming Services or Goods upon discovery thereof, and in any event, any such notice of warranty nonconformance shall be given no later than forty-five (45) days after the expiration of the applicable warranty period.
4. Customer will provide PSEG with a reasonable opportunity to perform corrective work to comply with warranties herein. All corrective work will be performed on a schedule to be mutually agreed upon. Customer shall be responsible to remove and replace any equipment or structure in order to provide PSEG with access to perform warranty work.
5. PSEG shall have no liability or obligation for anything arising out of these terms, in the event that the Customer breaches any of the requirements of Paragraph C of this Article.
- D. **Exclusivity of Warranties and Remedies.** The warranties set forth in these terms are exclusive and are in lieu of all other warranties, whether statutory, express or implied, including, but not limited to, any warranties or merchantability, fitness for a particular purpose or arising out of any course of dealing or usage of trade. The remedies set forth in these terms are the exclusive remedies of Customer for any breach, defect or anything arising out of the performance or nonperformance of these terms.

### SECTION 4 - INDEMNIFICATION AND LIABILITY

PSEG shall indemnify and hold Customer harmless for any claims, suits, costs, damages, losses, or judgments arising out of PSEG's negligent acts or omissions in connection with these terms. Customer shall indemnify and hold PSEG harmless for any claims, suits, costs, damages, losses, or judgments arising out of Customer's negligent acts or omissions in connection with these terms. However, the parties' entire liability and obligation under these terms shall not exceed the dollar amount of the Contract Price, as set forth in "Form of Proposal", and under no circumstances shall the parties be liable to each other for any special, incidental, indirect, punitive, or consequential losses or damages whatsoever (including for lost profits, time, or revenue) for anything arising out of the performance or nonperformance of these terms, whether claims for said losses or damages are premised on warranty, negligence, strict liability, contract, or otherwise.

**SECTION 5 - DELAYS AND FORCE MAJEURE.** Other than the obligation to pay money, the parties shall not be liable to each other for failure to perform or for delay in performance due to, any cause beyond their reasonable control: or fire; flood, strike, or other labor difficulty; acts of God; mandates, directives, orders, or restraints of any governmental, regulatory, or judicial body or agency; riot, embargo; fuel or energy shortage; delays in transportation; inability to obtain necessary labor, materials or manufacturing facilities from usual sources; or act of omission of any of the persons or entities employed by the parties. In the event of delay in performance due to any such cause, the date of performance or time for completion will be extended by a period of time reasonably necessary to overcome the effect of such delay.

SECTION 6 - RELATIONSHIP. The relationship of PSEG and Customer to each other shall be that of parties to a contract, and neither these terms or anything done pursuant to these terms shall be deemed to create any partnership, joint venture, or agency relationship between the two parties. There are no third party beneficiaries to these terms.

SECTION 7 - COMPLIANCE WITH LAW. The Parties shall comply with all applicable laws and regulations.

SECTION 8 - WAIVERS. No term or condition of these terms shall be deemed to have been waived and no breach excused unless such waiver or breach is in writing signed by the party claimed to have waived or consented to excuse. Either parties' failure to demand or insist, in any one or more instances, upon strict performance of these terms, or to exercise any rights conferred under these terms, shall not be construed as a waiver or relinquishment of its right to assert or rely upon any such terms or rights in the future.

SECTION 9 - APPLICABILITY OF TARIFF. The PSEG Tariff For Electric Service on file with the New Jersey Board Of Public Utilities is hereby incorporated in its entirety by reference, and any conflict or inconsistency between the terms and conditions of these terms and said Tariff shall be resolved in favor of the Tariff.

SECTION 10 - HEADINGS. The headings assigned to the sections of these terms are for convenience only and shall not limit the scope and applicability of the sections.

SECTION 11 - ENTIRE AGREEMENT. These terms, which includes the "Form of Proposal", constitutes the final, complete, and entire Agreement between the parties, and all prior discussions, negotiations, communications, proposals, or agreements, whether oral or written, are hereby superseded. Any statements, representations, terms or conditions, whether express or implied, other than those set forth in these terms may not be modified, altered, or amended in any way except in writing signed by duly authorized representatives of both the Customer and PSEG. These terms shall be governed and construed by the laws of the State of New Jersey.

SECTION 12 - CANCELATION PRIOR TO RECEIPT OF SERVICE. Termination of this Agreement by the Customer prior to completion of installation and receipt of service shall be done by written notice. WHEREAS, State is about to undertake the design and construction of Route 168 Merchant Street to  
 Ferry Ave Pavement Resurfacing \_\_\_\_\_ located in Audubon Park Borough, Audubon  
 Borough, Haddon Township, City of Camden, Oaklyn Borough, Woodlynne Borough &  
 Camden County \_\_\_\_\_, hereinafter called the "Project"; and

WHEREAS, the Project may require the construction of new, and/or the protection, relocation and/or  
 adjustment of facilities of the existing \_\_\_\_\_ Water & Sewer \_\_\_\_\_ system which is owned  
 and operated by the Utility; and

WHEREAS, Utility's legal right to occupy public right-of-way, subject to the conditions imposed by  
 the State, is in no way mitigated by this Agreement; and

WHEREAS, Utility is not obligated by State law or agreement to relocate its own facilities at its own  
 expense for this type of Project; and

WHEREAS, the provisions of the State's Accommodation of Utilities within Highway Right-of-Way  
 N.J.A.C. 16:25 and Code of Federal Regulations, 23 C.F.R. 645, Subpart B are applicable.

NOW THEREFORE, State and Utility, for the mutual benefits to be obtained, agree as follows:

- (1) The State and Utility shall cooperate in developing plans and cost estimates for their  
 respective work necessitated by the Project.
- (2) The Utility shall designate a responsible representative to coordinate its effort with those of  
 the State.
- (3) The State will, at its sole cost and expense, contract for and cause to be constructed, all items  
 indicated in the State's contract plans and specifications for the Project, related to existing and  
 proposed facilities owned and operated by the Utility.
- (4) The State will authorize and reimburse the Utility for its actual costs for design, review,  
 approval and inspection, for the protection, relocation or adjustment of its existing facilities  
 necessary to accomplish the Project.
- (5) The Utility's preliminary engineering design costs for correspondence, meetings and

exchanges of engineering information are eligible for reimbursement and the State will accept billing of these costs after this Agreement is fully executed and issued.

- (6) The Utility shall disclose and verify its existing facilities at no cost to State within the Project limits identifying the facility type, size and operating potentials.
- (7) The State will indicate the existing and proposed utility facilities, owned and operated by the Utility, and to be constructed by the State, in State's contract documents for the Project.
- (8) When the State proceeds to develop the Project plans, the State and Utility shall jointly identify potential conflicts between the Utility's facilities and the Project, and shall jointly develop a scheme for the protection, relocation, rearrangement and/or betterment of facilities in accordance with N.J.A.C. 16:25 Utility Accommodation to accomplish the Project.
- (9) Subsequent to the development of the above scheme with the approval of the State and concurrence of the Utility, the State will issue a "Utility Owner Design Authorization (Check List)" describing the utility work and authorizing the State's designer to finalize design plans, estimates, and schedules necessary to construct new, and/or protect, relocate, and/or rearrange facilities in concert with the Project, and incorporate them into the State's Project contract documents.
- (10) The State will develop a "Utility Agreement Modification" which may include a Utility Agreement Plan outlining work "To be performed by State's contractor at State Expense", estimated cost for field engineering, inspection and/or valve turning operations to be performed by Utility's personnel. This will be issued in the person of the Executive Regional Manager Team C (NJDOT).
- (11) The purpose of this Agreement is to cover all the required utility facility construction, protection, relocation, and rearrangement work necessitated by the Project; however, it is agreed that the State, in the person of the Executive Regional Manager Team C (NJDOT), will issue modifications to this Agreement to cover unanticipated work, resulting from Project activities and/or field conditions.
- (12) State will supply the Utility with a copy of the contract plans and specifications when the Project is advertised.
- (13) The State will request, by certified mail, the Utility to submit final invoices for costs incurred by the Utility upon; (a) completion of design; (b) completion of the utility work; or (c) cancellation of the Project. All such invoices shall be submitted to the State within sixty (60) days of this request. The State may not accept invoices for payment submitted after the sixty

- (14) All matters pertaining to subcontracted work, billing, estimates, survey control, extra work items and inspection responsibility shall be in accordance with the Memorandum Of Record dated January 10, 2013, entitled: "Procedures Governing Estimation of Costs, Requirements During Construction and Billing the New Jersey Department of Transportation for Public Utility Work", and in accordance with the Federal Regulations 23 CFR 645, Subpart A and with it being understood that where the State's Regulations are in conflict with the Federal Regulations, the Federal Regulations shall govern. Billing shall be based on accounting methods used by the Utility in conformity with the system of accounts adopted and prescribed by the Division of Local Government Services of the State of New Jersey. The matter of "Credit for Expired Service Life" has been considered for all items and where allowances apply, same are hereinafter specified in description of items and the cost summary.
- (15) The Utility will comply with the Buy America Federal Regulation requirements U.S.C. 313 and 23 CFR 635.410, for all steel and iron materials furnished by the Utility and its Subcontractors for permanent incorporation in this Project. Under this requirement, all manufacturing processes for steel and iron products shall occur in the United States including all melting, rolling, extruding, machining, bending, grinding, drilling and coating. The Utility Company shall submit a Buy America Commitment letter at the time of execution of this Agreement affirmatively stating that the Utility is committed to complying with all the requirements of the Buy America Federal Regulations. The State reserves the right to audit such records at the completion of the Project. The lack of these documents will be justification for rejection of the steel and/or iron product thus resulting in nonpayment for all work performed by Utility.
- With the Final Construction Invoice submission, the Utility shall submit a "Buy America Certification of Compliance" certifying that:
- All steel and iron products provided for permanent incorporation in the Project, were made from steel and iron that was melted and manufactured in the United States including the application of coatings which protect or enhance the value of the material.**
- Or if any material does not comply with these requirements, the Utility will indicate what material does not comply. The State may require the Utility to remove and replace material that does not comply with the Buy America requirements, at no expense to the Department and may deny the Utility reimbursement for all the relocation costs incurred by the Utility.
- (16) The Utility shall perform the work, specified herein, with its own forces wherever possible and only have that portion of the work performed by a consultant or contractor that the Utility is not adequately staffed or equipped to perform with its own forces.
- (17) The intention of this Agreement is that facilities which are removed, relocated, or disrupted

will be replaced in such a manner that shall result in services being restored to the status and degree of use as existed prior to said changes. The Utility and the State agree to jointly use their best efforts to relocate, adjust and/or abandon the existing facilities and construct any new facilities without detrimentally affecting or interrupting services to the Utility's customers. In the event during construction of the Project it is necessary to detrimentally affect or interrupt services, the Utility shall be notified at least 48 hours in advance, unless the particular circumstances dictate less notice.

- (18) The design of utility facilities intended to be constructed by the State for the Utility shall be approved by the Utility before the State includes such facilities in the State's contract documents before the Project is advertised.
- (19) In no case will the State pay for betterment of facilities, nor will the State pay any costs for work performed for the sole benefit or convenience of the Utility, the State's contractor, or the Utility's contractor.
- (20) Utility facilities constructed under the terms of this Agreement shall become the sole property of the Utility and the Utility shall be solely responsible for their operation, repair, and maintenance.
- (21) The State will obtain and bear the cost of all permits, environmental or otherwise, relating to the construction of new, and/or the protection, relocation and/or rearrangement of existing facilities, as necessitated by the Project, whether the necessary utility work is within or outside of the highway right-of-way. However, should the Utility choose to install facilities that constitute betterment, then it is the sole responsibility of the Utility to obtain the permits necessary for said betterment. It is further understood that should the Utility desire to install additional facilities, at a future date within the highway right-of-way, the Utility shall obtain the appropriate Utility Permit from the authority having jurisdiction over the highway. This Agreement is the Utility Permit for the work authorized herein.
- (22) Subject to provisions of the New Jersey Tort Claims Act, N.J.S.A. 59:1-et seq., the State will be responsible for personal injuries and property damage caused by the actions of the State, its employees or agents which arises out of this Agreement. Any claim for such personal injury or property damage must be filed in accordance with N.J.S.A. 59:8-1 et seq.
- (23) Subject to the provisions of the New Jersey Tort Claims Act, N.J.S.A. 59:1-1 et. Seq., the Utility will be responsible for personal injuries and property damage caused by the actions of the Utility, its employees or agents which arises out of this Agreement. Any claim for such personal injury or property damage must be filed in accordance with N.J.S.A. 59:8-1 et seq.
