2026 ANNUAL ACTION PLAN
30-DAY PUBLIC REVIEW AND COMMENT PERIOD

The City of Camden Department of Finance – Bureau of Grants Management is making available its 2026 Annual Action Plan for a 30-day public review and comment period. This notice is being republished to correct the previously published notice, which did not include the funding allocations for each grant program or the dates of the required 30-day public comment period.

This notice supersedes the previously published Public Notice for the 2026 Annual Action Plan. The 30-day public review and comment period is being reissued to ensure compliance with HUD's citizen participation requirements.

As a U.S. Department of Housing and Urban Development (HUD) Entitlement Community, the City of Camden has been allocated \$4,743,977.27 for Program Year 2026 through the following HUD programs:

- Community Development Block Grant (CDBG): \$2,318,939.00
- HOME Investment Partnerships Program (HOME): \$769,863.27
- Emergency Solutions Grant (ESG): \$209,197.00
- Housing Opportunities for Persons With AIDS (HOPWA): \$1,445,978.00
